Inbound Travel Accident Insurance

Highlight of coverage

- ✓ THB 750,000 coverage for medical expenses due to accidents and illnesses (including COVID-19) and THB 1 million for accidental death and disability
- ✓ Includes telemedicine
- ✓ Coverage starts immediately after immigration clearance
- ✓ No waiting period. No deductible
- ✓ International visitors to Thailand are encouraged to have travel insurance
